महोदय,

उपरोक्त विषय के सन्दर्भ में अतिरिक्त निदेशक पंचायती राज विभाग हि०प्र० द्वारा उनके कार्यालय पत्र सं० PCH-LC012/1/2022/291293/2023 दिनांक 05/12/2023(प्रति संलग्न) के माध्यम से सूचित किया गया है कि ग्राम पंचायतों के माध्यम से ग्रामीण क्षेत्रों में लागू किए जा रहे पाइप जल आपूर्ति योजनाओं के संचालन और रखरखाव (O&M) के लिए प्रशिक्षित मानव संसाधन की उपलब्धता के लिए राष्ट्रीय जल जीवन मिशन (NJJM) ने कौशल विकास पहल "नल जल मित्र कार्यक्रम" की शुरुआत की है, जिसका उद्देश्य कौशल विकास और उद्यमिता मंत्रालय के साथ सहयोग में स्थानीय लोगों को प्रशिक्षित करना है। नल जल मित्र को प्रशिक्षित करने के लिए ग्राम पंचायत क्षेत्र के मौजूदा वॉटर गार्ड से चयन किया जाएगा।

प्रशिक्षित वॉटर गार्ड को संबंधित ग्राम पंचायत का नल जल मित्र नामित किया जाएगा तथा वह ग्राम पंचायत के पूर्ण निरीक्षण और नियंत्रण के तहत कार्य करेगा। नल जल मित्र वर्तमान व्यवस्था के अनुसार में जल शक्ति विभाग के पे-रोल पर ही रहेंगे तथा आवश्यकता होने पर जल शक्ति विभाग द्वारा सिफारिश के अनुसार इसे बदला जा सकता है। नल जल मित्रों का चयन जल शक्ति विभाग द्वारा जारी की जाने वाली मार्गदर्शिका के अनुसार होगा।

पहले चरण में प्रति पंचायत एक वॉटर गार्ड को नल जल मित्र के रूप में प्रशिक्षित किया जाएगा। इसके बाद बड़ी ग्राम पंचायतें एक से अधिक वॉटर गार्ड को नल जल मित्र के रूप में प्रशिक्षित करवा सकती हैं। प्रशिक्षण केंद्रों का चयन हि.प्र. कौशल विकास निगम द्वारा ग्राम पंचायतों के साथ मिलकर किया जाना है। ग्राम पंचायतों के पास 15वां वित्त आयोग (Tide Grant for water related works) के तहत उपलब्ध धनराशि में से प्रशिक्षण की लागत राशि को वहन किया जायेगा।

अतः आपसे अनुरोध है कि आप अपने अधीनस्थ सभी ग्राम पंचायतों को 15वां वित्त आयोग (Tide Grant for water related works) के तहत उपलब्ध धनराशि में से प्रशिक्षण की लागत राशि को वहन के लिए अनुपूरक जीपीडीपी में 25000/- से 30000/- का प्रावधान करने व राशि हस्तांतरित करने के निर्देश जारी करने की कृपा करें। बैंक का नाम और खाता संख्या शीघ्र ही साझा किया जाएगा। इसके अतिरिक्त, जल शक्ति विभाग द्वारा इस संबंध में जारी की जाने वाली मार्गदर्शिका के अनुसार ग्राम पंचायतों को उनके क्षेत्र में कार्यरत वॉटर गार्डों में से नल जल मित्र का चयन करने के निर्देश जारी करने की कृपा करें।

Sir,

Please refer to the subject cited above. As you are aware, Jal Jeevan Mission is completing four years since launch of the mission in August 2019 and in four years 9.76 crore rural households have been given tap water connections. For ensuring availability of trained human resource for Operation and Maintenance (O&M) of the piped water supply schemes being implemented in rural areas through the Gram Panchayats the Department of Drinking Water and Sanitation National Jal Jeevan Mission(NJJM) has rolled out a skill development initiative "Nal Jal Mitra Program" to train local people in collaboration with Ministry of Skill Development and Entrepreneurship.

In this regard it is to inform you that it has been decided that Nal Jal Mitra would be selected from the existing water guard of the gram panchayat area for imparting training, as Nal Jal Mitra. Trained Water Guard will be designated as Nal Jal Mitra of the concerned gram panchayat and will work under the overall supervision and control of the gram panchayat. Nal Jal Mitras shall continue to be on the payroll of the Jal Shakti Dept, as at present. Replacements, as and when required, will be recommended by the Jal Shakti Deptt. Nal Jal Mitras will be selected as soon as the guidelines are issued by the Jal Shakti Vibhag.

In the first phase one water guard per panchayat will be trained as Nal Jal Mitra. Thereafter bigger gram panchayat may train more than one water guard as Nal Jal Mitra. Skill centers are to be identified by HPKVN in advance

along with Geographical mapping of training centers with gram panchayat to ensure smooth training. Funds available with Gram Panchayats under the tied grants for water under the Fifteenth Finance Commission tied grants for water , shall be utilized for meeting the training costs.

You are therefore requested to direct all the Gram Panchayats to make provision of Rs. 25000/- to 30000/ in supplementary GPDP under 15th F.C. tied grants for water, to provide the same to skill centers as training cost. Name and the account number of the Bank will be shared in due course of time. In addition Gram Panchayats may be directed to select NaL Jal Mitra out of Water Guards in your Panchayats as per guidelines to be issued by the Jal Shakti Vibhag in this regard.

It has with reference to this office letter No.-5951-65 dated 02-12-2023 vide which it was requested that one person from each GP shall be nominated by GPs under Nal Jal Mitra Programme. In this regard, directions have been also issued from the Additional Director, Panchayat Raj Department, H.P. to all the District Panchayat Officers (DPOs) to make provisions of Rs. 25000/- to 30000/- in supplementary GPDP under 15th F.C. tied grant for Water and to nominate the Nal Jal Mitra out of Water Guards for NJM training (Copy of letter enclosed). NJM training to be funded from 15th F.C. funds and nominations of NJM has to be done by Panchayats. It has been proposed that water guards who are already deployed in panchayats shall be trained as NJM and where water guard as per Guideline is not available Multi Tasking Staff (MTS) shall be nominated.

You are therefore requested to closely coordinate with the PR & RD officers, officials at district level and direction shall be issued in the field to complete the process of nominations in upcoming Gram Sabhas. JEs/BRCs shall ensure that each panchayat be communicated regarding programme with details of eligible Water Guards to be nominated as per NJM Guidelines so that list of batches may be prepared in a time bound manner.

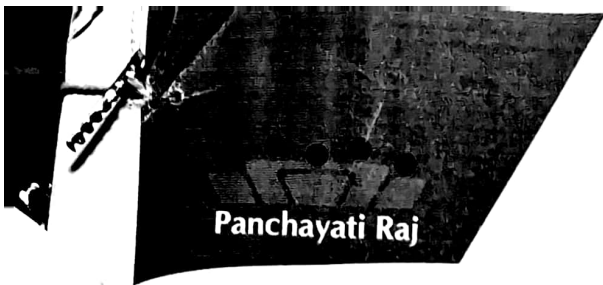
